## (Dua Pose)

The pose I am doing you will see often on the Temple reliefs that we will visit on the tour. Dua means adorations and when you see it on the reliefs it is being done to acknowledge the essence of a person that is beyond physicality.

This pose is depicted numerous times on the reliefs in most of the temples and often combined with making some sort of offering.

What was worthy of such adoration to the ancient Kamitan aka Egyptian people you may be wondering? That which is “**real.**”

That which is physical, or physicality is always in a state of deterioration. Hence it is always changing and does not stay the same. However, there is an “**essence**” that gives rise to physicality which *never* changes. It is the same today as it was yesterday and will be the same tomorrow. This “**essence**” is infinite and transcendental. It is this “**essence**” that the people of ancient Africa considered to be “**real.**” It is this “**essence**” that they continuously gave reverence to through the Dua pose.

Lawrence Mathews (Anpu Waset), has studied the culture and philosophy (the “Mysteries”) of the ancient native peoples of the land called Kamit/Kmt (Egypt) by its inhabitants for the past 15 years under the guidance of Dr. Muata Ashby. 
